1. Background

- 1.2. From **The internet site** website you can upload own video clip, access url video clip and use **The internet site**'s stock videoclips for your development of your web tv channel.
- 1.3. From **The internet site** website you can further download the **The internet site** video blog creation tool which you may use for creation of own video content for the tv channel.
- 1.4. On **The internet site** website you can under this Agreement, as a "Developer" of a web tv channel, create and distribute a web tv channel.
- 1.5. **The internet site** will license, by you the tv channel and uploaded video content for the tv channel, for non-commercial and commercial use in its original form, without any compensation to be paid by you.
- 1.6. If you do not accept any condition in this Agreement, you shall not neither from **The internet site** website download the **The internet site** video blog creation tool and the tv creation application, nor upload any by you developed content.

2. Not accepted Egentv.se content

- 2.1. You may not at **The internet site** upload any content containing parts and material that can be found to be disturbing, molesting, mobbing or threatening including, but not limited to persecution of a race or an ethnic group, its background, colour of skin, sexual behaviour or religion, spreading of any kind of pornographic, including childpornographic and sexual violence or threat.

3. Egentv.se Developer License

- 3.1. **The internet site** grants you, as a Developer the right to download and use the **The internet site** video blog creation tool and the use of Egentv.se tv channel creation tool for your development of a web tv channel and the right to distribute the web tv channel by having it embedded into other web sites.
- 3.2. **The internet site** grants you, as a developer the right to use video clips that are available at the **The internet site** website, at no cost. The use of the video clips is for personal use, solely for the purpose of developing a web tv channel.
- 3.3. You may not make the **The internet site** video blog creation tool or the tv channel creation tool available to any third party nor use any of them for any other purpose than allowed under this Agreement.
- 3.4. You may not make any video clip, downloaded from the Egentv.se website, available to any third party, nor sell them or in any other way re-distribute them other than embedding the tv channel at other web sites.
- 3.5. The "Tradenames" ' **The internet site** ', the 'tv channel creation tool' and the ' **The internet site** video blog creation tool' are the property of **The internet site**, with a high commercial value.

- 3.6. When embedding your developed web tv channel into other 3<sup>rd</sup> party web sites, you may not do that if it conflicts with the 3<sup>rd</sup> party website regulations.
- 3.7. **The internet** site has the right to embed a third party logotype in the skin of the TV channel that the user has created.
- 3.8. **The internet site** has the right to include short TV or video commercial into the user created TV channel. Either as an intro commercial or as a commercial inbetween the video clips in the playlist.
- 3.9. There may be charges for the usage of the **internet site's** services as communicated to the user through the registred email address. These charges may change from time to time. User accept charges by providing card number details or details for payment for other payment service. The internet site has the right to close a user account if the claimed payment not is adjusted.

You will neither in any way use any of the Tradenames nor claim any right to any of the Tradenames.

#### 4. License Grant

- 4.1. You, as Developer, hereby grants **The internet site** an exclusive worldwide , royalty free license to with the right to sublicense, use any and every by you at **The internet site** uploaded content in its original form, without any modifications.
- 4.2. You guarantee, that **The internet site's** use of your uploaded content does not infringe any third party intellectual property right.

#### 5. Termination

- 5.1. **The internet site** has the right at any time, to delete from its system any content that is in violation of any rules of this Agreement.
